# Terms and conditions for Cat Friendly Clinic Competition 2021

The Cat Friendly Clinic competition (the 'Competition') is subject to the following Terms and Conditions ('Conditions') and by entering the Competition you agree to be bound by them.

1. By entering the competition, you warrant to International Cat Care ('iCatCare') that all information submitted by you regarding yourself and your competition entry ('Entry') is true and accurate and complete in every respect. iCatCare reserves the right to verify any information provided in connection with your Entry.

**2. All Entries must be received by 10.00am (BST) on 6 December 2021 ('Closing Date').**

3. The Competition is open to staff of Cat Friendly Clinics who are resident in the United Kingdom, and also to staff of Cat Friendly Clinics who are resident outside of the United Kingdom provided that they are able to enter the Competition without breaching any law or regulation of the jurisdiction in which they are resident.

4. iCatCare shall be entitled to assume that the manager of any staff member who is less than 18 years old has consented to that person's entry into the Competition. Entrants may be required to provide proof of identity and if aged under 18, should be able to demonstrate to iCatCare's satisfaction that their manager has given their consent to such entry.

5. iCatCare reserves the right in its absolute discretion to disqualify any entrant if it believes that an entrant has breached any of the Conditions, any applicable law (including without limitation copyright law) or has infringed the intellectual property of any other person. Each entrant acknowledges and agrees that any failure to comply with the Conditions may lead to iCatCare disqualifying that person, without iCatCare being required to give any reason for such disqualification or granting any opportunity for challenge.

6. Employees of iCatCare, their relatives or any agents (or their employees) are not eligible to enter the Competition.

## Competition entries

**7. Entries should be submitted in .MOV or .MP4 format and be no longer than 60 seconds.** Videos which are not of sufficient quality may be discounted from the competition. **Entries should be submitted by the Closing Date (6 December 2021)** and in the manner set out in these conditions. Failure to do so may result in disqualification.

8. iCatCare accepts no responsibility for the return of any Entries which are submitted in hard copy form as well as electronic form.

## Prize-winners

9. Prize-winners will be selected and notified by **1 April 2022** at the latest, by email. Six videos will be selected as finalists and from those two winning videos will be selected by the iCatCare judges, one for each category. All six shortlisted entries will be invited to the iCatCare CFC 10-year anniversary event on 29th of April 2022. The two overall clinic winners will also receive 2 tickets each to the ISFM Rhodes congress in 2022.

10. There are 2 prizes available, each consisting of 2 tickets to the ISFM Rhodes congress in 2022. These tickets entitle the bearer to entry to the ISFM congress in Rhodes including lectures, exhibition and any other events which are included in the standard ticket price. Travel, accommodation, subsistence, and any other costs associated with attending the congress are not included.

## Liability

11. iCatCare accepts no responsibility for Entries lost, damaged, or delayed whether due to transmission errors, website malfunction, computer error or otherwise. Intellectual property rights and data protection.

12. Entrants agree to their videos appearing in Cat Friendly Clinic promotional materials, as well as on facebook, twitter and other social medias. Videos' may be shared with Cat Friendly Clinic Sponsors.

13. By submitting an Entry in the Competition you grant to International Cat Care a non-exclusive royalty-free worldwide commercial licence unlimited in time, to use the Entry (whether or not it wins the Competition) in all formats and in any medium of communication, in full or in part, and for all promotional purposes which International Cat Care shall consider appropriate. You represent and warrant to International Cat Care, with the intention that International Cat Care shall rely on such representation and warranty, that each of your Entries is original, and that you own each of them exclusively and have the right, without the permission of any other person or legal entity, to license to International Cat Care the rights in the Entry for all the purposes contemplated in these Conditions.
